#### Sale of a Re-Development Opportunity to Experienced Local Investor

Then, our Asset Management Team was retained as property manager, subsequently bolstering security, curing city violations, renovating vacancies, solving collections issues and raising the overall performance of the property. Economic occupancy at the property has already increased from 50% to 79% in the first 90 days and tenant morale has never been higher.
